



## GENERAL FEES IN FINLAND 1.1.2012

### 1. APPLICATION FEE (Licences)

After receipt of the application the application fee will be invoiced. It is not until the application fee has been paid that the application will be dealt with. The travel costs outside the Nordic countries for inspection visits will be charged separately. No application fee will be charged for registration.

### 2. ANNUAL FEE (Licences and registrations)

The annual fee is charged per licence in advance and calculated upon the estimated turnover in the current year. The annual fee of the first year will be charged to the nearest month from the date of awarding the licence but at least the minimum fee will be charged.

<b>Products:</b> 0.3 % for the annual turnover of the labelled product in Finland.	<b>Minimum fee</b> EUR 1 500 <b>Maximum fee</b> EUR 34 000
<b>Services:</b> 0.3 % for the annual turnover of the labelled service in Finland.	

In case the company has several licences in the same product group two maximum fees **EUR 68 000** per product group will be charged at the most.

### 3. CONTROL FEES

The costs caused by testing, inspections and other measures required by the Ecolabelling criteria shall be paid by the licensee/applicant. Travel costs will be charged EUR 500/visit/production plant outside the Nordic countries and EUR 1500/visit/production plant outside Europe.

### 4. EXCEPTIONS

**Micro companies** in accordance with the definition of European Commission (less than 10 employees with a turnover of ≤ EUR 2 000 000/year) can be allowed a **50 % discount of the application fee.**
